### **Public Health Perspectives on Alcohol Regulation**

Much of the debate about alcohol legislation and litigation often explores alcohol industry concerns about economic issues. Public health advocates will discuss balancing alcohol regulation with public health considerations.

#### Legal Developments in Fighting Drunk Driving

The scourge of drunk driving remains at the forefront of many legislative and judicial actions. Hear the latest on developments across the country on policies and litigation related to drunk driving prevention efforts.

#### **21<sup>st</sup> Amendment Litigation Roundtable**

With nine of the twelve federal circuits addressing 21<sup>st</sup> Amendment matters in the last two years, alcohol litigation remains a crucial issue facing states. This session will analyze conflicting circuit opinions, responses to the litigation (including federal legislation) and the new makeup of the United States Supreme Court.

#### International Relations, Alcohol, Public Health and the 21<sup>st</sup> Amendment

This panel will explore a variety of issues that public health and government agencies consider when involved in foreign trade debates related to alcohol. From dealings with foreign alcohol manufacturers to the public health considerations of alcohol regulation, or states' rights under the 21st Amendment, complex issues are present in an increasingly globalized alcohol marketplace.

#### Alcohol Regulation's Important Role in Tax Collection

The taxation of alcohol is important to state revenues especially in these challenging budget times. States utilize a wide variety of tools to collect alcohol taxes, some of which are not available with other products. Learn the various state laws that allow states to collect alcohol taxes and fees, such as a Texas law that increases its ability to audit and collect alcohol taxes.

#### Defending State Liquor Laws Under the 21<sup>st</sup> Amendment: A State Perspective

States face obstacles when confronted with 21<sup>st</sup> Amendment challenges. This panel of assistant state attorneys general and regulators – who have been involved in litigation regarding the 21<sup>st</sup> Amendment—will explain the sharp learning curve on this topic. They will also offer advice for defending a state against a 21<sup>st</sup> Amendment challenge.

#### **The Delicate Balance Between the Tiers**

The American system of state-based alcohol regulation was set up to provide separate and accountable tiers for states to monitor the alcohol industry. Over the past 75 years, states have enacted countless measures to define and regulate the marketplace. Laws that help enforce this separation of tiers-such as franchise laws and tied house restrictions-will be examined, as will current regulatory and litigation related matters in these fields.

#### The Role of Religion in Alcohol Regulation

Religion has played a role in many parts of public policy, and alcohol is no exception. The perspective of religious groups has been a focus of many debates about alcohol regulation for centuries. This panel will explore what lessons have been learned and what current alcohol matters are attracting the attention of the faith community.

#### **Ethics Safari: Surviving the Legal Practice Jungle**

This is a new and challenging interactive seminar that ventures into shadowy areas, exploring recent developments in legal ethics as well as new tools for anticipating and dealing with ethics dilemmas. Engaging hypothetical scenarios, most based on recent cases and lawyer experiences, will become the catalyst for wide-ranging group discussion and debate.
