21st Amendment and Supreme Court Roundup

This panel will address recent alcohol-related litigation around the country as well as highlight important U.S. Supreme Court decisions that could impact alcohol regulation in the states.

STOP Act Report

Six years ago, Congress passed and President George W. Bush signed the Sober Truth on Preventing (STOP) Underage Drinking Act into law. This landmark legislation provided new federal and state focus on underage drinking efforts and recognized the primary role that states play in regulating alcohol. This panel will discuss activities undertaken and the lessons learned since its passage.

The Latest on Drunk Driving Issues

Mothers Against Drunk Driving (MADD) began with a mother who lost her child in a drunk driving crash. She turned grief into positive change; her work and the work of so many others started a movement that has saved hundreds of thousands of lives. But, even today, one in three people will be involved in an alcohol-related crash in their lifetime. MADD leaders will discuss the latest in their campaign to eliminate drunk driving.

The Impact of Alcohol Regulation on Local Law Enforcement

Perhaps no stakeholder is more directly affected by changes in alcohol regulation than law enforcement officials, yet too often their input and expertise is not sought before new laws are passed. This panel will explore the impact policy changes have on law enforcement, demonstrate effective ways law enforcement can be engaged in policy debates before change is implemented and discuss the challenges local officers face in a changing alcohol marketplace.

Deregulation by Defunding?

Federal and state alcohol regulators have been asked to do more with less and now face the prospect of doing everything with nothing. With deficits looming, legislators continue to look to cut spending, even in agencies that are responsible for regulating an industry that provides substantial government revenues. This panel will explore the dangers of defunding alcohol regulators and highlight recent success stories in providing additional resources to regulate the alcohol industry.

Legal Issues Facing Alcohol Distributorships

The legal issues that independent alcohol distributors confront are as diverse as the selection of products they provide.

Distributor general counsels will discuss their responsibilities, experiences, lessons learned and what the future may hold.

Public Health and Alcohol

Alcohol is intoxicating and has public health implications. This panel will review the challenges facing public health stakeholders across the country, their efforts to engage more stakeholders and emerging trends.

Alcohol Pricing Regulation: Domestic and Abroad

From legislative and judicial battles in the states to the modern day debate about minimum alcohol pricing in the United Kingdom, the issue of government regulation is at the forefront. This panel will explore the law and policies behind pricing regulations and the future of this form of regulation.
